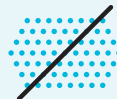

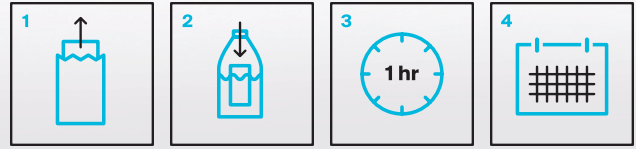

HOW TO ACTIVATE



Step 1: Tear open the foil package and remove the white inner pouches. **DO NOT OPEN WHITE INNER POUCH.** **Step 2:** Add the pouches to an opaque (not clear) ProKure container filled with five gallons of water. **Step 3:** Agitate for one minute at 15-minute intervals until full activation at one hour. **Step 4:** Use stored formula within 15 days of activation.
